- D’fhiontair thráchtála amháin atá an maoiniú seo ar fáil (nó aon fhiontar nach dteann faoi théarmaí Acht na dTeangacha Oifigiúla, 2003¹)
- Ar bhonn maoiniú meaitseála 50:50 idir an t-iarrthóir agus Foras na Gaeilge a bhronnfar an maoiniú seo. Ní mór maoiniú meaitseála a bheith ar fáil ag an iarrthóir. Is é an t-uasmhéid atá ar fáil faoin scéim seo ná €3,000/£2,200, ag brath ar an tionscadal beartaithe
- Tá ciste na scéime seo teoranta agus beidh tairiscintí deontais déanta ar bhonn tús áite don iarratas is tuisce faighte, agus níl aon chinnteacht go ndéanfar tairiscint sa chás go mbeidh an buiséad idithe.

- This funding is available to commercial enterprises only (or any enterprise that does not fall under the terms of the Official Languages Act, 2003¹)
- This funding will be awarded on a 50:50 match-funding basis between the applicant and Foras na Gaeilge. The applicant must have matching funding available. The maximum available under this scheme is €3,000/£2,200, dependant on the proposed project
- The budget of this scheme is limited and the number of grant offers will be made on a first-come basis and there is no certainty of receiving an offer when the scheme budget has expired.
- Classification of Grant Categories:**
New or Replacement Business Signage: match-funding to the maximum value of €1,500/£1,100
Irish/bilingual packaging: match-funding to the maximum value of €1,500/£1,100. Disposable shopping bags will not be eligible for funding
Websites: Websites will be awarded funding based on the relevance and practicality of the site. In relevant cases, match-funding to the maximum value of €1,000/£750 will be awarded
Other Bilingual/Irish Language Materials: match-funding to the maximum value of €1,000/£750 will be awarded to other relevant business materials as deemed appropriate and necessary
- This scheme is aimed at small and medium sized enterprises only
- Foras na Gaeilge will not provide any funding in the case where such an initiative is already being funded by another state body (e.g. Údarás na Gaeltachta²)
- A draft version of the proposed bilingual/Irish language item must accompany the application. Applicants must ensure that the translation to Irish on this draft version is accurate
- The amount of funding awarded is entirely dependent on the amount and visibility of Irish on the bilingual/Irish language item
- The completed item must be ready by November 30th
- Funding will be awarded on a receipt basis. Funding will not be paid retrospectively, i.e. for items already in use
- Enterprises seeking funding must have a bank account, in the name of the enterprise
- There is a limit to the numbers of applications that Foras na Gaeilge can accept, and only one application per enterprise, per annum, shall be accepted
- Funding will be granted, on a first come, first-served basis, upon fulfillment of the above criteria, as well as completion of the following application form, and signing of the attached contract.
