Although the work is taking longer than the organisation anticipated, it is certain that great work is being done and that a very valuable and practical piece of work available for Irish Language instructors as a result. Samples of the lessons have been made available and the work is of a high-quality.

A time extension to June 2011 so that the work may be completed and a budget amendment has been requested as follows:
