04.152 REPORTS FROM THE COMMITTEES OF FORAS NA GAEILGE

The Grants Committee

The Board approved the consultation document for Scéim na nOifigeach Gaeilge (Irish language Officer Scheme) and it was agreed that the consultation process would commence on 3 March (**Appendix 1**). The Board approved the Colmcille minor capital grant scheme for development and partnerships (**Appendix 2**). The Board noted the information notes from Cumann na bhFiann and Gaeloideachas (**Appendix 3**). The Board noted the information note regarding Scéim na nOidí (**Appendix 4**).

The Board approved the recommendation that €240,000 be provided to Cumann na bhFoilsitheoirí, for the Scheme which provides marketing supports for the Irish language Publishing Sector (Scéim le Tacaíocht Margaíochta a Sholáthar d'Earnáil na Foilsitheoireachta Ghaeilge). This would be provided over a period of 3 years, with the budget for year 2 depending on satisfactory results for the business plan of year 1, and the year 3 depending on satisfactory results for year 2. It was agreed that Cumann na bhFoilsitheoirí Gaeilge would be asked to provide a biannual report. It was noted that an expenditure breakdown was not made available for the Grants Committee (Coiste na nDeontas) meeting, but that it was provided subsequently.

05.152 STATEMENT OF EXPENDITURE

The Board noted the statement of expenditure of January 1st to January 31st 2017, and the 2017 yearly budget. The Board approved the list of commitments and the list of written off grants. Comparison figures were asked to be provided covering a 3 year period regarding the commitments. A question was also raised about the entirety of Foras na Gaeilge's funding and it was reported that a graph detailing this covering the timeframe of 2008-2016 was previously circulated, and could again be made available. The Director of Corporate Services circulated a declaration of disclosure of information in relation to the 2016 Accounts and asked the Board to send it to the executive completed.

08.152 RECOMMENDATION REGARDING NEW FORAS NA GAEILGE OFFICE

The Chief Executive gave a brief presentation on the background of the subject – reason for moving, the process from 2013 onwards, and the communication with staff, and the protected disclosure.

The Chief Executive explained that discussions regarding the move had begun in 2013 when it was disclosed to staff that all staff members from both Dublin Offices would be brought under one roof. He noted that there had been continuous communications with the Office of Public Works since then and that staff members had been notified on an ongoing basis of the lack of development with the search for an office.

He stated that a misunderstanding had arisen from the meeting with the trade unions at the Partnership Committee meeting before Christmas. The Chief Executive apologised to the Board for this misunderstanding. He said that there was no doubt that there was a considerable contingent of staff from Merrion Square were against moving office, and that there was also staff members in favour of a move, senior management included. He reported that SIPTU was against the move to Amiens Street and that IMPACT was in favour of the move.

He referenced the protected disclosure that was reported in January and he explained that it was made available to the Chairperson, and that the process was made clear. The Chairperson was satisfied with that. The Chief Executive said that a copy of the report was made available to both sponsor departments and that it was discussed at The Audit Committee on February 7th

The Audit Committee

The Chairperson of The Audit Committee stated that lengthy discussions had taken place regarding the question. The Committee had been informed that internal auditor was satisfied that best practice standards had been adhered to, and that there was evidence that contact was made and appropriate correspondence had taken place with the OPW, and that all possible avenues with the OPW had been explored.

The Development Committee

The Deputy Chairperson stated that the Development Committee had discussed in great detail the recommendation relating to the new Office and explained that the Committee didn't have all the pertinent information as the Chief Executive had planned a meeting with SIPTU that afternoon, and as a result the Chairperson of the Committee decided not to make a recommendation.

Deliberations of the Board

Extensive discussions had taken place regarding the question. Every Board member had an opportunity to speak. The possibilities of Merrion Square were discussed, along with a Gaeltacht Quarter in Dublin, as well as media coverage. It was agreed that the Board should be notified immediately about breaking news in the media relating to Foras na Gaeilge. Reference was made to the staff's concerns regarding safety and it was recommended that everything should be done to deal with those concerns and in an effort to raise staff morale.

The executive clarified certain points. It was explained that the lease agreement would give Foras na Gaeilge and the landlord stability respectively, and it was stated that rent increases would be limited and would not rise above market rent rates. It was also stated that contact had been made with other offices in the Amiens Street area and that there had been no incidents regarding personal safety but that there had been incidents where vehicles parked on the street had been broken in to since they had moved to the area (some of which had been there since 2001).

The Chairperson gave a summation of the discussion. He reported that confirmation had been received from the Department for Communities and that confirmation from the Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs expected shortly.

The Chairperson asked the Board to cast a vote regarding the new office on Amiens Street. 9 Board members were in favour with one Board member voting against. The Board approved the move to Amiens Street on the condition that confirmation was received from the Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs.

Project Costs:

• There is an increase in the budget for the joint Project with Glór na nGael and the Irish for families scheme.

- The cost of Féasta as a joint project is factored in.
- An increase of €2,500 added to the development of the website.
- Slight increase in cost regarding campaigns for new provisions.

Authorisation:

Clár na Leabhar Gaeilge

Workshops were organised as part of Scéim na nOidí 2015 (The Teacher Scheme 2015) and at the last workshop, feedback about the scheme was requested from those who were working under the scheme, and recommendations were welcomed. It was recommended that the name be changed and that the term 'Oide' (teacher) would no longer be used. It is intended that the name be changed to 'Scéim Meantóireachta Fhoras na Gaeilge' (Foras na Gaeilge's Mentoring Scheme) and that the terms 'mentor' and 'apprentice writers' would be used in describing those who work together under the scheme.

03.153 SENIOR MANAGEMENT REPORT

The Chief Executive reported that:

There were implementation plans created to move the staff based in North Frederick Street to Merrion Square in May. Public events will no longer take place in the Main Hall as staff will now be placed there.

Clarifation has not yet been received from DAHRRGA regarding additional funding — it is not yet known how much of the €750,000 announced before year end for the Foras Teanga will be provided for Foras na Gaeilge. The projects that DAHRRGA will approve remain unknown. The funding will not be approved for any projects previously mentioned in the Business Plan or in the Corporate Plan, nor will expenditure be approved for all-island or projects in Northern Ireland. Expenditure will not be approved for projects spanning longer than the current year. The following recommendations will soon be presented to DAHRRGA and these projects will be valued above €300k according to a rough estimate. Applications and accurate estimates will be sought when the projects are approved by DAHRRGA. More than €400k, depending on applications, will be spent on relocating staff from Frederick Street and Merrion Square, moving Áis and moving to the new office.

03.154 SENIOR MANAGEMENT REPORT

The Chief Executive explained that:

• Authorization has not yet been received from DAHRRGA regarding additional funding – it is not yet known how much of the €750,000 announced before year end for the Foras Teanga will be provided for Foras na Gaeilge. The projects DAHRRGA will approve also remain unknown. There is no authorization to spend any funding on projects previously mentioned in the business plan, nor is expenditure authorized on any all-Ireland projects or on projects based in Northern Ireland. Expenditure will not be permitted for any projects that extend further than a calendar year.

It was asked that the risk register is amended to include the danger of not being able to utilise funding before the end of the year unless authorization is received from the DAHRRGA.

- That authorization had been received from the DAHRRGA for the new offices on Amiens Street. The terms of the lease are to be agreed without delay. There is optimism that the new offices will be ready before the end of 2017.
- That the lease for the Foras na Gaeilge offices on North Frederick Street would be coming to an end at the end of May and that staff members from North Frederick Street would be moved to Merrion Square North on a temporary basis until the new offices are ready.

It was asked that a copy of the sponsor department's letters with the official authorization would be made available to Board members for information.

• That there would be revised guidelines from the Department of Communities regarding the budget of 2016/17 at the end of June 2017, as a stop-gap arrangement since the northern jurisdiction was without a government.

04.154 REPORT FROM THE FORAS NA GAEILGE COMMITTEES

The Grants Committee

The Board approved the recommendations made in regards to the 2017 Theatre Companies Scheme (**Appendix 1**). It was stated that there was a recommendation from the Committee that the next share of the budget would be put aside for new groups and that support would be made available to help them in filling application forms.
