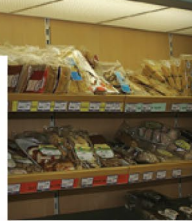
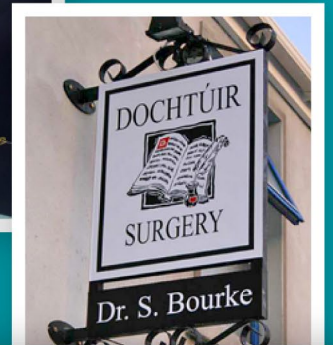
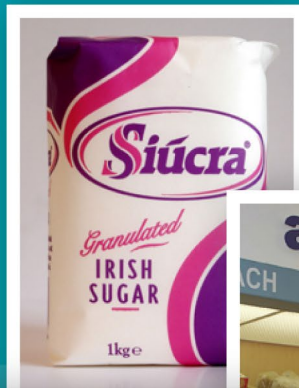
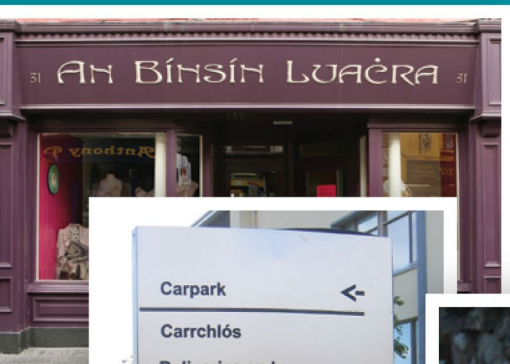




# Scéim Tacaíochta Gnó Business Support Scheme

## Critéir Mhaoinithe

- D'fhiontair thráchtála atá i mbun trádála faoi láthair agus do thrádálaithe aonair incháilithe atá an maoiniú seo ar fáil (nó aon fhiontar nach bhfuil faoi théarmaí Acht na dTeangacha Oifigiúla (Leasú), 2021<sup>1</sup>)
- Ar bhonn maoiniú meaitseála 50:50 idir an t-iarratasóir agus Foras na Gaeilge a bhronnfar an maoiniú seo. Ní mór don iarratasóir cuid de chostas iomlán an tionscadail a chlúdach. Is é an t-uasmhéid atá ar fáil faoin scéim seo €3,000/£2,7000 - ag brath ar an tionscadal beartaithe
- Tá ciste na scéime seo teoranta. Bronnfar deontais ar na hiarratais incháilithe san ord a gheofar go dtí go mbeidh buiséad na scéime caite.

### Rangú na nDeontas:

- **Comharthaíocht gnó nó athchurtha:** maoiniú meaitseála suas le €1,500/£1,350
- **Pacáistíocht Ghaeilge/dhátheangach:** maoiniú meaitseála suas le €1,500/£1,350. Ní bheidh málaí siopadóireachta aon uaire incháilithe le haghaidh maoiniú
- **Suíomhanna Gréasáin:** Bronnfar maoiniú ar shuíomhanna gréasáin bunaithe ar ábharthacht agus praiticiúlacht an tsuímh. I gcásanna áirithe, ceadóimid maoiniú meaitseála suas le €1,500/£1,350
- **Ábhair dhátheangacha/Ghaeilge eile:** ceadóimid maoiniú meaitseála suas le €1,000/£900 d'ábhair ábhartha eile ghnó má mheasaimid iad a bheith oiriúnach agus riachtanach
- Tá an scéim seo dírithe ar fhiontair bheaga agus mheánmhéide amháin (trádálaithe aonair incháilithe san áireamh)
- Ní chuirfidh Foras na Gaeilge aon mhaoiniú ar fáil má tá tionscadal mar seo á mhaoiniú cheana féin ag eagrais eile stáit (e.g. Údarás na Gaeltachta<sup>2</sup>)
- Ní mór dréachtleagan den ábhar Gaeilge nó dátheangach beartaithe a bheith leis an iarratas. Ní mór d'iarratasóirí a chinntiú go bhfuil dóthain téacs Gaeilge ar an dréachtleagan a cuirtear ar fáil. Déanfaidh Foras na Gaeilge measúnú agus profáil air seo
- Tá méid an mhaoinithe a bhronnfar ag brath go hiomlán ar mhéid agus ar infheictheacht na Gaeilge ar an gcomharthaíocht/ábhar Gaeilge nó dátheangach
- Caithfear an t-ábhar críochnaithe a bheith ar fáil faoi 31 Deireadh Fómhair
- Is gá cruthúnas ar an tionscadal críochnaithe a sholáthar taobh istigh den bhliain reatha, sula ndéanfar íocaíocht a phróiseáil. Cuirfimid an maoiniú ar fáil ar bhonn admhálacha. Ní íocfaimid maoiniú go cúilghabhálach, i.e. ábhair atá déanta cheana féin
- Ní mór cuntas bainc, in ainm an fhiontair, a bheith ag fiontair atá ag lorg maoiniú
- Tá teorainn le líon na n-iarratas is féidir le Foras na Gaeilge a ghlacadh, agus ní ghlacaimid ach le hiarratas amháin an fiontar in aon bhliain amháin
- Nuair is infheidhme, agus más cuid d'iarratas oifigiúil atá á dhéanamh le haghaidh pleanála iad na comharthaí, ní mór d'iarratasóirí cead pleanála iomlán (de réir bhrí alt 36 den [Acht um Pleanáil agus Forbairt 2000](#)) a sholáthar.

2. Is é [Údarás na Gaeltachta](#) an t-eagrais atá freagrach as tacaíocht a thabhairt do ghnólaicthe atá lonnaithe sa Ghaeltacht.

## Funding Criteria

- This funding is only available to commercial enterprises, and eligible sole traders, that are currently trading (or any enterprise that does not fall under the terms of the Official Languages Act (Amendment), 2021<sup>1</sup>)
- This funding will be awarded on a 50:50 matchfunding basis between the applicant and Foras na Gaeilge. The applicant must commit to contributing to the overall cost of the project. The maximum available under this scheme is €3,000/£2,700 - depending on the proposed project.
- The budget of this scheme is limited. Grants will be awarded to eligible applications in the order received until the scheme budget is spent.

### Classification of Grant Categories:

- **New or Replacement Business Signage:** match-funding up to €1,500/£1,350
- **Irish/bilingual packaging:** match-funding up to €1,500/£1,350. Disposable shopping bags will not be eligible for funding
- **Websites:** We will award funding to websites based on the relevance and practicality of the site. In relevant cases, we will award match-funding of up to €1,500/£1,350
- **Other bilingual/Irish language materials:** we will award match-funding up to €1,000/£900 for other relevant business materials if we deem them appropriate and necessary
- This scheme is aimed at small and medium sized enterprises only (including eligible sole traders)
- Foras na Gaeilge will not provide any funding if such an initiative is already being funded by another state body (e.g. Údarás na Gaeltachta<sup>2</sup>)
- A draft version of the proposed Irish language or bilingual material must accompany the application. Applicants must ensure that there is sufficient Irish language text on the draft version supplied. Foras na Gaeilge will assess and proof this
- The amount of funding awarded is entirely dependent on the amount and visibility of Irish on the Irish language or bilingual signage/material
- The completed item must be ready by 31 October
- Proof of the completed project must be provided within the current calendar year, before payment is processed. We will provide funding on a receipt basis. We will not pay funding retrospectively, i.e. for items already made
- Applicants seeking funding must have a bank account in the name of the business
- There is a limit to the number of applications that Foras na Gaeilge can accept, and only one application per enterprise is permitted in any one year
- Where applicable, and if the signage is part of an official application made for planning, applicants must provide full planning permission (in accordance with section 36 of the [Planning and Development Act 2000](#)) for the development of those goods.

2. [Údarás na Gaeltachta](#) is the body responsible for supporting businesses located in the Gaeltacht.
