#### 06.140 STATEMENT OF EXPENDITURE UNTIL 31 DECEMBER 2015

The Board noted the statement of expenditure until 31 December 2015. The Director of Corporate Services explained that the exchange rate had an effect on the Foras na Gaeilge end of year budget. He noted that the exchange rate would be taken into account on an ongoing basis going forward.

#### 08.140 SENIOR MANAGEMENT REPORT

The Chief Executive explained that:

- The Scéim Pobail Gaeilge (SPG 2016-2020) was approved at the meeting of the North South Ministerial Council (NSMC) on 06 November 2015. The main changes of the scheme are:
  - Amount of schemes increased from 19 (as it currently stands) to a maximum of 26, but to reduce the funding to each scheme,
  - ➤ To increase the length of the scheme from 3 to 4 years  $\in$ 1m each year rather than  $\in$ 1.2 (as it has been),
  - Reduce the Officers salaries from 100% to 80%
  - ➤ A maximum of €4,000 / £3,250 as current costs, a reduction on the current costs from scheme to scheme,
  - The current groups can not apply for other Foras na Gaeilge schemes but that they can help other groups in the area to apply for the schemes,

Both changes requested by DCAL to the Board members were discussed and both changes were agreed: To allow the groups to apply for the schemes and to increase their current costs to  $\{6,000 \mid £6,500 \text{ a year, changes which DCAL said were requirements of the Minister.}\}$

- Grants were approved for two groups under "Together Building a United Community" a project which is part of OFMDFM:
  - Arts Ekta (1601005) a group presenting other cultures to primary school pupils and the pupils then hold an exhibition for the entire school and parents. £10,000 is approved for the project, which will be taking place in some schools in the north.
  - ➤ Raidió Fáilte (1601006) to create a connection with the unionists on Shankill road and to provide media training for the youth of the area. £6,000 was approved for this project.

The funding will be paid through Foras na Gaeilge and therefore the Board, for the audit scope, will have to approve the funding of £6,000 for Raidió Fáilte and they noted the funding for Arts Ekta.

#### 08.142 SENIOR MANAGEMENT REPORT

The Chief Executive stated that:

• In the Assembly on the 15<sup>th</sup> March Minister Ní Chuilín announced a "Gaelacadamh" and during the debate she said:

"Regarding the dictionary for the Irish language, Foras na Gaeilge has spent millions of pounds of public money, so it needs to be published. In my opinion, if it is not published this year, it will lose all credibility. I believe that, when groups on the ground are struggling and there is the notion that additional public money from this Government and the Irish Government is being ploughed into a dictionary project that people cannot see an outcome to, it will not be given the support that it has received unless it is published by the end of this year."

What she had to say was untrue but echoed what certain other people had said during the campaign against the new SPG (Irish Language Community Scheme). For the record:

- ➤ €6.088 million was the total budget approved for the dictionary project in 2010 and we have always remained within that. No additional funding was sought since then.
- > 25% of this budget comes from DCAL, €1.52m or £1.065;
- ➤ Over 90% of the dictionary has been published and is already available online and through the app and we are on track to achieving the 100% target in June of this year;
- Monthly reports are sent to the Departments on the dictionary project and the project is discussed regularly at the monitoring meetings with the Departments: the 'credibility' of the project was never questioned;
- > De Bhaldraithe and Ó Dónaill are available online.

This is already known by the Minister and the officers in the Departments.

#### Recommendation

After continuous discussions with Comhairle na Gaelscolaíochta it came to light that some committees had problems at the planning stage regarding project costs for Irish medium nursery school. Following these discussions it was recommended that the grant would be provided over a three year period i.e. that Foras na Gaeilge will provide 80% of the total project cost (maximum of £4,000) to the committee on the understanding that the committee would then provide 20% of the total cost sought in the first year,

eg. Total project cost=£5,000, (£4,000 from Foras na Gaeilge and £1,000 from committee.)

Total project cost = £3,500, (£2,800 from Foras na Gaeilge and £700 from committee.)

This part of the grant will be provided to cover architectural, publicity and development costs to cover the language plan.

The grant for year 2 and 3 will be conditional in terms of the success of the committee in year 1.

# **04.145 REPORTS FROM FORAS NA GAEILGE COMMITTEES Grants Committee**

The Board approved the budget changes for Raidió na Life (Appendix 1). A question was asked regarding the payscales and it was noted that the payscales are in line with those in the public service. The salary levels in the different projects funded by Foras na Gaeilge were discussed and it was explained that the amount paid by Foras na Gaeilge was in line with those in the public service in both jurisdications depending on where the projects were based, in accordance with the Foras na Gaeilge Board decision. A question was raised regarding additional payments for charities, a subject which is currently being widely discussed in the news, and it was agreed that the Grants Committee would discuss this question again.

#### **The Audit Committee**

It was noted that the applications for the tender process for a new Internal Auditor were assessed and that Crowe Horwath were again chosen for a three year period. It was noted that they have received a draft contract and that the fee would remain the same for the period of three years from 15 August 2016.

### **08.145 THE NEW IRISH ENGLISH DICTIONARY**

J. Ó Labhraí gave a presentation on the different stages of the dictionary project and discussions followed. S. Ó Coistealbha noted that he had requested information regarding the targets set out for the project and that he had still not received the information. It was explained that there were many documents involved, that the information was requested during summer holidays, and that staff did not have the opportunity to send the documents out to the board members with the documents for the meeting, that this information was now available and that he would receive it today. The changes in project deadlines were described and current deadlines were laid out as they stand at present. Reference was made to a joint statement from the NSMC on 10 July 2015 regarding a printed version being made available in 2017 and it was explained again that this was the current deadline as it stands. The Board discussed the dictionary and concerns were raised that the printed version would be put back to 2018 as a result of recommendations that were in front of the Board, and that some of the members were reluctant to accept them as a result. Eventually the Board saw the sense of the recommendations and the following two recommendations

were accepted regarding the printed version of the dictionary and it was noted that NSMC approval would need to be sought in their regard:

#### **Recommendation 1**

- (a) It was accepted that the printed version would need to be separated from the current dictionary project and, accordingly, that this project is finished.
- (b) Staff were asked to prepare a business case in this regard for the Sponsor Departments and for the NSMC.

### **Recommendation 2**

It was accepted that a printed version should be published by the end of 2018 and to deal with it as a stand-alone project, including the recommendation approved on 01 July 2016:

- research the demand for a printed version:
- to include the 2016 Caighdeán Oifigiúil;
- increase the educational provision;
- add to the usual provisions that would be expected in a dictionary such as this;
- add to the provision on the English language in Ireland;
- increase headword sets according as required; and
- to undertake trans-dictionary editing.

It was confirmed that a printed version would exist by the end of 2018 as stated in Recommendation 2 above. A question was raised regarding the Dictionary Committee and it was agreed that the question would be added to the programme when the full Board would be put in place.

### 09.145 SENIOR MANAGEMENT REPORT

An updated copy of the senior management report was distributed and the Chief Executive explained that:

- The departments had now changed their minds and asked us to employ a recruitment agency on contract to oversee the competition for the CEO position.
- That two grants on the list for 'Scéim na nImeachtaí Óige' (The Youth Events Scheme), which were presented to the Board, were not included as part of the calculations in the 'synopsis' provided (the total recommended amount):

#### 02.150 MINUTES AND MATTERS ARISING

The Board discussed the new office. The Director of Corporate Services distributed a document regarding comparative information sought by the Board and it was discussed. It was explained that the Office of Public Works (OPW) were not happy to provide Foras na Gaeilge with a long-term lease for the office on Frederick Street or for the office on Merrion Square.

It was stated that the office on Merrion Square was not suitable as an office for the staff currently based there and that it would cost up to €500,000 to properly refurbish it, to make the office safe and appropriate for the staff who would be relocated from Frederick Street. A question was asked as to whether it was not the responsibility of the OPW itself to refurbish the building but it was stated that Foras na Gaeilge was not mentioned on the list that they had regarding this and that this question relates to the terms of the lease.

Concern was displayed regarding the location of the particular new office discussed. Concern was also raised on the risks surrounding becoming subject to private landlords in relation to future increase in rents. Furthermore, concern was raised in relation to the reduction in status for the organisation and for the language itself upon moving from the current location in Merrion Square to a location in the Connolly Station area. A report was given on the different choices looked at to deal with the issues in finding an office, information was given regarding the different possibilities, and the different rent rates in the city. It was explained that it was particular challenge in the Dublin market at present, which restricted the possibilities open to the organisation as a result. It was explained that the organisation was attempting to deal with this challenging question and to find a suitable solution but at the same time without negatively impacting on the budget received for grantees and the Irish Language Community. The Executive stated that the current office on Merrion Square was not healthy as an office – it was mentioned that there was a leak in the top of the building, that there were offices without proper windows and that floors were slanted. It was explained that the access for the disabled was limited.

A question was raised regarding how staff felt about the new location being looked at and it was stated that staff were concerned about the safety of the new area, and that a staff meeting would be held to discuss this. The Board noted that it was important that

the opinions of the staff be listened to and that their requirements be met. The Chief Executive stated that staff safety would have to be made a priority. It was explained that the Board would have to make a decision between adjusting the 2017 budget to spend up to €500,000 on Merrion Square to make it appropriate for the extra staff members who were to transfer from the Frederick St office or continue to explore the possibilities in relation to the new site under consideration. The executive was asked to provide a report to the Board at the next meeting regarding the view of staff on the matter. The Board accepted the main heads of agreement for the new office on the understanding that there was no legal obligation attaching to them and that the Board would have another opportunity to make a decision on the proposal from the executive when further information was available from the consultation with staff in both the Dublin offices.
