### Guidance on completing Safeguarding Policy Checklist (South)

This guidance relates to the checklist that organisations providing relevant services are required to complete. Your organisation must decide whether it provides a relevant service or not.

Please note that your organisation was required **under law** to be compliant with Children First National Guidance 2017 **from 11 March 2018** onwards.

- If your organisation decides that they **do** provide a relevant service the checklist must be completed. If you answer **X** to any of the questions, please indicate what actions you are undertaking or intending to take to ensure compliance and state a timeframe for doing so **or** provide an explanation for why it is not in place or necessary for your organisation.
- If your organisation decides that it **does not** provide a relevant service you must inform Foras na Gaeilge in writing and you are not required to complete this checklist.

Foras na Gaeilge may withdraw funding from organisations which are not compliant after this date.

Foras na Gaeilge **do not** require a copy of your organisation’s Safeguarding Policy or evidence of compliance but we do require a signed copy of the checklist.

The terms ‘Safeguarding Policy’ and ‘Child Protection and Welfare Policy’ are commonly used, however for consistency we will use the term Safeguarding Policy in this document. Both terms are the same and cover all aspects of safeguarding/child protection.
